- III. PRESIDENT'S REPORT: Anne Podney welcomed new SDDTA director, Jeff Greenwald. She also recognized and congratulated tennis professional Angel Lopez of San Diego Tennis and Racquet Club for achieving 40 years of excellent tennis instruction in San Diego. - VII. TOURNAMENTS: Tony Perez provided an update on the Holiday Tournament at Mesa College which went well, he said. Good weather and around 100 entries. 8 courts were available, and the college was very cooperative. Simon Shen was the tournament director and Tony Perez the referee. There is a new sanctioned tournament at La Costa in April. Brian Blumenfield will be the tournament director. The District tournament will have a wheelchair division. We should be able to attract players from LA and Orange County.
